

Confirmation of receiving funds from Oxfam in Korea

This letter confirms that Oxfam Great Britain (Registered Charity in England and Wales Number 202918) received three instalments totalling 175,584 GBP (283,672,646 KRW) from Oxfam in Korea in 2021 and 2022 as detailed below:

August 2021: 62,481 GBP (101,372,072 KRW)
December 2021: 61,026 GBP (99,339,116 KRW)
March 2022: 52,077 GBP (82,961,458 KRW)

The donations received from Oxfam Korea were consolidated with Oxfam Great Britain's other income sources and helped to support beneficiaries all over the world to overcome poverty and suffering.

Oxfam Great Britain has a wide portfolio of programmes that work in three interlinked ways: humanitarian interventions, development programmes, and campaign and advocacy programmes. Because Oxfam Great Britain implemented more than 900 programmes in the financial year of 2021/22, directly or indirectly via Oxfam International, we are including two examples in the appendix.

Please note that the followings are provided as examples of expenditure and are programmes that successfully completed or are currently undertaken by Oxfam Great Britain.

1. Diversifying and Boosting Livestock production in Sierra Leone

Project period: July 2019 to July 2023 (with report period: 1st Aug 2021 - 31st Jul 2022)

Key partners: Child Fund and Slaws Animal Welfare Society (SLAWS)

<u>Project locations</u>: Sierra Leone, Districts: Koinadugu, Boboli, Kono, PortLoko

Total programme value: £1,421,400

<u>Final beneficiaries & or target groups</u> (for the reporting period): 2450 livestock farmers from 490 households, (60% women and 30% youth), 40 FBOs of 20 farmers each, 160 smallholders (60% women and 30% youth),60 Community Animal Health Workers (CAHWs), 4 District Livestock Management Committees (LMCs), 4 District Councils, 3 private sector groups including livestock investors and supermarkets will be engaged for value chain addition and marketing, MAF and its LSD, Sierra Leone Agricultural Research Institute (SLARI)

<u>Executive summary of the action:</u> The objective of the project is to boost agriculture and food security through increased and diversified livestock production in Sierra Leone. Although all the actions planned were not accomplished, progress was made, and the following main actions were completed during the reporting period in pre-selected districts.

The project successfully delivered training to 800 farmers on Improved Production Techniques and created awareness among farmers on livestock diversification to promote positive behaviours and attitudes towards livestock acceptance through farmer-to-farmer engagement, radio discussions, and IEC materials distribution. Other achievements included vaccination of both local and improved breeds of 20,000 poultry and 5,000 ruminants (goats) to prevent diseases outbreak and maintain animals; strengthening of 4 district livestock committees across project implementation areas to engage in advocacy issues; establishment of 4 district farmer forums/platforms; support provided by CAHW with essential drugs to continue the provision of veterinary services. 40 Master farmers were trained as lead farmers and are providing extension services, to 40 FBOs were supported with startup capital to form women and youth groups and start livestock enterprises, a market information system was developed to provide access to market and diseases information, and the livestock quality standard guild for Sierra Leone was launched and popularised.

2. Naseej- Connecting voices and action to end violence against women and girls in the MENA region

Project period: March 2019- August 2022

Project locations: Iraq, part of a wider programme in Yemen and Occupied Palestinian Territory

Total programme value: £1,669,294

Number of people to be reached by the project: 20,000 women and 800 men in Iraq. Wider programme reaches 50,300 women and 1,800 men

PROJECT SUMMARY

The project is part of a wider programme that will address sexual and gender-based violence (SGBV) across three fragile and conflict-affected countries in the Middle East: Yemen, Iraq and the Occupied Palestinian Territory. This project is led by Oxfam in collaboration with two MENA (Middle-East and North Africa)-based universities, Women's Rights Organisations (WROs) and Civil Society Organisations (CSOs). The goal is to channel support to WROs and CSOs through a grant scheme in order to help them better prevent and respond to incidences of sexual and gender-based violence. This will be done through four project areas 1) tackling discriminatory gender and social norms 2) offering increased and greater quality support for survivors 3) improving confidential and effective reporting mechanisms 4) improving legal and policy measures to protect and promote rights of women.

EXPECTED RESULTS BY THE END OF THE PROJECT

- 1. Nine partner WROs have been supported to be more effective and independent in their work on SGBV.
 - Establish grant scheme for WROs/CSOs (focused on 3 areas: strengthening support, referral services and reporting systems; transforming social norms; strengthening development and implementation of national SGBV legislation)
 - Conduct organizational and technical capacity assessments for selected grantees
 - Host workshop for grantees to train them on finance, procurement, reporting, visibility, and compliance.
 - Deliver comprehensive capacity-building packages for grantees including training on management, project cycles, safeguarding and technical support
- 2. WROs in the target countries have been supported to effectively provide services to respond to SGBV in conflict settings
 - Map and analyse existing support service providers and referral systems
 - Improve women and girls' knowledge of SGBV support services (health, legal, psychosocial) and reporting mechanisms through outreach at individual, household and community level

- Create or strengthen safe spaces where women and girls can discuss SGBV and seek peer support
- Establish or improve referral systems targeting marginalised and remote communities
- Provide appropriate health, legal, and psychosocial support services to SGBV survivors

 training for health, legal and psychosocial service providers in the clinical management of rape
- **3.** Men, boys, women and girls will have increased awareness of their roles in preventing SGBV and in supporting survivors
 - Work with communities to challenge gender and social norms that perpetuate SGBV, including by working with men and boys to address harmful notions of masculinity
 - Awareness and capacity building sessions with men and boys on topics of masculinity and femininity, positive fatherhood, and non-violent communication, engaging men and boys (including public figures) in becoming allies in and champions of women's rights issues
 - Grantees will be supported to identify women leaders and potential agents of change in each area and support them in building their leadership capacities through trainings, shadowing and coaching
 - Engage social leaders, influencers and role models in local and national dialogue and advocacy on ending SGBV
- 4. The global knowledge base on SGBV in conflict will be strengthened to inform current and future interventions and advocacy
 - Produce multi-country research report on SGBV in conflict with a focus on the most vulnerable women and girls
 - Conduct baseline study/formative research to understand community perceptions of SGBV and women and girls' barriers to reporting SGBV and to accessing support services
 - Collect testimonies to document and advocate against violations of women's rights under International Humanitarian Law (IHL)
 - Develop and disseminate knowledge and learning products (knowledge products will identify promising approaches and best practices used by grantees that can be scaled up and/or adapted to other countries and contexts)
- 5. WRO alliances and/or networks at national and regional level will be supported and strengthened
 - Organise regional meetings, learning events and best-practice exchanges between WROs working on SGBV in MENA
 - Support advocacy for strengthening and reform of national-level legislation
